1. CALL TO ORDER

The Citizens Advisory Committee (CAC) Meeting of the Addison Park District was called to order at 6:02 p.m. by Chair Michael Sampey on Wednesday, June 6, 2012 at the Community Rec Center, 120 East Street, Addison, DuPage County, Illinois.

5. POOL REPORT & TOUR – MISSY MEYER, FACILITY SUPERVISOR

Missy Meyer began by providing an update of the facility. She informed the committee that the facility opened Saturday, June 2 and will be open for the season, seven days a week, until Sunday, August 19. New pool renters will be using the facility this season. Two out-of-town swim teams, Wheaton and Westmont, are renting the pool in the AM's. They will be using the 50 meter lanes, which have not been utilized for several years. This will provide the facility with a new revenue stream.

Programming begins on Monday, June 11 and there will be five sessions of swim lessons this season. Lessons will conclude on August 16. Also, we are offering several other swim programs; lunchtime lap swim, adult, dive, swim team prep private swim lessons to name a few.

New at the facility this year includes; refinishing of the diving boards, furniture and lane lines. The splash pad will again be open during lessons. The committee asked if a set of stairs can be purchased for the facility. The staff will look into stairs for the facility for ease of access in the water. This item, due to not being budgeted for the 2012 season, may have to be delayed until the 2013 season.

After Missy reviewed the facility operation, the committee proceeded to the facility for a tour.

6. COMMITTEE MEMBER COMMENTS

Debi Gayon inquired about having a tour of the parks. The committee discussed touring of all 24 parks in Addison. After a brief discussion, it was decided to schedule a tour Wednesday, August

29. The tour will begin at Community Park. We will tour as many parks as possible. Additional tour may need to be scheduled.

Sam Gunda inquired about having a juice bar at Club Fitness. A full service juice bar, provided by an outside vendor was suggested. Michael will send the request to Greg Vitale, Club Fitness manager. It was reported that Greg is scheduled to attend the next CAC meeting.

7. STAFF REPORT

Mr. Bill Menelli was welcomed to the committee. The park board recently appointed Bill for a two year term. Welcome Bill!

Staff provided information on the upcoming events, Bike Fest and Addison Foundation Golf outing, volunteers are needed. Thank the committee members who volunteered for the Park Pride event.
