**1. CALL TO ORDER**

The Citizens Advisory Committee (CAC) Meeting of the Addison Park District was called to order at 6:04 p.m. by Committee Vice-Chair Oscar Olivia on September 16, 2010 at Club Fitness, 1776 West Centennial Place, Addison, DuPage County, Illinois.

Pool lessons, which have been very strong, have seen a slight decline in the first fall session. A new Fitness and Aquatics Supervisor, Elisa Phillips, has been hired just recently. Greg encouraged the committee to take a tour of the facility.
