1. CALL TO ORDER

The Citizens Advisory Committee (CAC) Meeting of the Addison Park District started at 6:30 p.m. on Thursday, November 10, 2016 at the Community Recreation Center, 120 E. Oak Street, Addison, DuPage County, Illinois. No quorum was established.

-The inaugural Craft Beer Fest is being held in the Centennial gym from 1pm-5pm.

-The Polar Express, scheduled for December 4th has been sold out for about 3 weeks.
