5. New Business

a) FY Budget Initiatives - Executive Director Hermonson handed out the preliminary budget book to the board. She explained that we have plenty of time to review and will answer questions for the next few weeks.

She reviewed the highlights and the different sections of the book and took questions from the board. Discussion took place on the fund balance account and our future bond payment in 2023.

Superintendent of Recreation, Leslie DeMoss gave a grief overview on the Recreation budget and recapped the past year as well as future opportunities for each of the facilities.

Executive Director Hermonson explained how this year was the first budget process for most of our new staff. They did a great job, and each year we will get more detailed. She continued reviewing each section with emphasis on the Capital budget breakdown. This included discussion on the Club Fitness roof leakage, future playground replacements, and parks projects.

b) Intergovernmental Agreement Frogs Swim Team – Superintendent of Recreation Leslie DeMoss recapped the swim team dilemmas in Addison and Wood Dale, and how they will be merging into one team for this season. He stated that the contract will run through August and when the season is finished, they will assess the program to see how well it went. Discussion took place on if we had any fiscal responsibilities and other communications.

6. Policy & Planning Report

- a) Biometric Information Privacy Policy Executive Director Hermonson, explained that we were not compliant with this privacy act. We should have a policy on this, and this is getting us up to compliance after this is approved.
- b) 6.2 Smoking Policy Update Executive Director Hermonson gave an update that we are waiting on the policy from our attorney.

7. Director Report & Commissioner Comments

Executive Director Hermonson gave an update on the Army Trail Nature Center meeting that was held recently. Discussion then took place on Lydia Park, and some options we have on the parcel of land.

Westwood Park – Just information for this year because the high school asked if they could use it for soccer. We don't have an intergovernmental agreement for it. We gave them permission to use it and we will maintain it. An agreement will be put together at a later date.
