



THE ADDISON PARK DISTRICT ASSUMPTION OF RISK AND LIABILITY WAIVER

ADDISON PARK DISTRICT PROGRAMS AND FACILITIES ARE DESIGNED TO PROVIDE SAFE LEISURE AND RECREATION FOR ALL PARTICIPANTS. WHEN PARTICIPATING IN ANY PROGRAM OR AT ANY PARK DISTRICT FACILITY, THERE EXISTS THE POSSIBILITY OF INJURY.

USERS OF THE PARK DISTRICT FACILITIES AND PARTICIPANTS IN PARK DISTRICT PROGRAMS ACKNOWLEDGE THAT THEY ARE VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES, AND, THEREFORE, ASSUME ALL RISK OF INJURY WHILE DOING SO. FURTHER, FACILITY USERS AND PROGRAM PARTICIPANTS DO HEREBY WAIVE ANY AND ALL CLAIMS OR CAUSES OF ACTION ARISING FROM SAID PARTICIPATION AND RELEASE THE ADDISON PARK DISTRICT FROM ANY CLAIMS RELATING TO SAID PARTICIPATION IN ANY SUCH ACTIVITIES.

DESPITE ALL PRECAUTIONS TAKEN BY THE PARK DISTRICT, THE PARK DISTRICT CANNOT GUARANTEE THE HEALTH OR SAFETY OF THOSE USERS OF PARK DISTRICT FACILITIES OR PARTICIPANTS IN PARK DISTRICT PROGRAMS. IT IS UNDERSTOOD THAT THE COVID-19 VIRUS CAN BE CONTRACTED THROUGH EXPOSURE AND INTERACTION WITH OTHER INDIVIDUALS POSSESSING THE VIRUS.

THIS ASSUMPTION OF RISK AND LIABILITY WAIVER ALLOWS USERS AND PARTICIPANTS TO GAIN ACCESS TO PARK DISTRICT FACILITIES AND PARTICIPATE IN PARK DISTRICT PROGRAMS WITH THE UNDERSTANDING THAT THEY VOLUNTARILY ASSUME ALL RISKS ASSOCIATED WITH ANY EXPOSURE TO COVID-19, INCLUDING BUT NOT LIMITED TO, SUFFERING ANY MEDICAL CONDITIONS RESULTING THEREFROM. FURTHER, THE UNDERSIGNED AGREES TO RELEASE, INDEMNIFY AND HOLD HARMLESS THE PARK DISTRICT AND ITS RESPECTIVE ELECTED OFFICIALS, OFFICERS, EMPLOYEES, AGENTS, REPRESENTATIVES AND SUCCESSORS OR ASSIGNS FROM ANY AND ALL LIABILITY, DAMAGES, LOSSES, SUITS, DEMANDS, OR CAUSES OF ACTION AGAINST SAID ENTITY AND INDIVIDUALS, TO THE FULLEST EXTENT PERMITTED BY LAW, ARISING OUT OF, OR RELATING IN ANY WAY TO, THE USE OF THE ADDISON PARK DISTRICT FACILITIES OR PARTICIPATION IN ADDISON PARK DISTRICT PROGRAMS AND THE POTENTIAL EXPOSURE TO THE COVID-19 VIRUS.

THIS GENERAL RELEASE AND HOLD HARMLESS SHALL BE CONSTRUED BROADLY TO PROVIDE A FULL RELEASE AND WAIVER TO THE MAXIMUM EXTENT PERMISSIBLE BY LAW.
