WHEREAS, the Addison Park District, DuPage County, Illinois (the "District"), is a duly organized and existing Park District created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Park District Code of the State of Illinois, and all laws amendatory thereof and supplementary thereto, including the Local Government Debt Reform Act of the State of Illinois, as amended; and

WHEREAS, the Board of Park Commissioners of the District (the "Board") intends to sell bonds in the amount of \$2,120,000 for the payment of land condemned or purchased for parks, for the building, maintaining, improving and protecting of the same and the existing land and facilities of the District and for the payment of the expenses incident thereto (the "Bonds"); and

WHEREAS, the Bond Issue Notification Act of the State of Illinois, as amended, requires the Board to hold a public hearing concerning the Board's intent to sell the Bonds before adopting an ordinance providing for the sale of the Bonds:

Now, Therefore, Be It and It is Hereby Ordered by the undersigned President of the Board of Park Commissioners of the Addison Park District, DuPage County, Illinois, as follows:

- 1. I hereby call a public hearing to be held at 6:00 o'clock P.M. on the 25th day of September, 2023, in the Community Recreation Center, 120 East Oak Street, Addison, Illinois, in the District, concerning the Board's intent to sell the Bonds and to receive public comments regarding the proposal to sell the Bonds (the "Hearing").
- 2. I hereby direct that the Secretary of the Board (the "Secretary") shall (i) publish notice of the Hearing at least once in the Daily Herald, the same being a newspaper of general circulation in the District, not less than 7 nor more than 30 days before the date of the Hearing and

- (ii) post at least 72 hours before the Hearing a copy of said notice at the principal office of the Board, which notice will be continuously available for public review during the entire 72-hour period preceding the Hearing.
- 3. Notice of the Hearing shall appear above the name of the Secretary and shall be in substantially the following form:






The chart below shows the total number of party rentals hosted for August, which was 29.

The chart below shows the monthly rental decreased slightly in August. The total party rental revenues totals for August were \$16,125.













Below is a chart of the total revenues for August, which includes merchandise and concessions sales.

The Pareto Chart below shows each area of Links & Tees sales for the start of the fiscal year 2023.











Below is a chart of the total number of Athletic Gym Rental guests served in August.





Athletic / Gymnasium Rental Revenues



Board Report: August

As we transition from summer into the autumn season, our team has made significant strides in organizational efforts, facility cleanliness, and customer service improvements. This groundwork ensures that we enter the fall season fully prepared and optimized for the increased activity we typically observe. Historically, as the temperatures drop, we experience a surge in member registrations. To cater to this demand, we are introducing 3-4 new classes, maintaining a consistent offering of 50-55 classes per week.

Currently, we boast 1,867 memberships with an average daily check-in of 400 members.

I am pleased to report notable progress in terms of member engagement, club culture, received commendations, facility cleanliness, and overall utilization of Club Fitness over the recent months.

Our dedication to upholding the highest standards of cleanliness and equipment maintenance remains unwavering. In this regard, special acknowledgment goes to Bill, our Janitorial Supervisor, and Julio, our Equipment Technician, for their relentless efforts and commitment to excellence.

Marketing & Communications

General Updates:

- Production began on the Winter 2023 2024 Activity Guide. Since the guide is digital, content is refreshed as needed, and reposted to reflect all current programming if changes occur. A mobile friendly link (single page view) and a desktop view link (double page view) will be posted with a custom landing page to create the most user-friendly experience. In addition, we add registration links to the digital guide, so users can directly link to the program on RecTrac. Printed copies will be placed in racks at Community Recreation Center and Club Fitness.
- We continue to work with RecTrac to reconfigure our registration landing package to be more user friendly in finding programs.
- 2023 September/October Senior Highlights was released the 1st week of August.
- **Sponsorship:** Clarendale purchased a 6-month ad in the Senior Newsletter (\$250.) Orthodontic Experts purchased a 6-month sponsorship package (\$720), and Ad-Park Pediatrics purchased a \$500 Major Sponsorship package of Candy Carnival. Streamwood Behavioral Hospital is also considering sponsorship with the park district.
- **Signage:** Marketing continues to work with other departments on directional and compliance signage.
- Community Outreach: The Marketing Manager continues to attend the ARC (Addison Resources Connect) and District 4 PTA Council meetings. Through these networking opportunities, we share information about our programs and events directly with District 4 and District 88, as well as other important members of the community. In addition, we hosted a tent at National Night Out (8/1), Rock 'N Wheels (8/10, 8/17, 8/31), at table at the Addison Public Library's Back to School Resource Fair (8/12), and participated in the Addison Medinah Shriners Parade on 8/27. The Westernettes also did an interview with Don Figuerelli on Addison TV.
- Translations: Preschool, Before & After School Care and Candy Carnival flyers were translated into Spanish, and all of these marketing materials have been racked at both Community Rec Center and Centennial Rec Center.
- **Web Site:** We are currently meeting with the registration software organization to update and improve the user experience on the site.

Social Media Updates:

- Initiatives have been taken to increase communication with the community through social media channels. New photos have been taken across all programs to help highlight to the community what the district has to offer.
- 77 posts completed throughout August on both Facebook and Instagram.
- Facebook likes grew by 12 in August.

- Facebook followers in August were 3,288 and 1,344 on Instagram.
- APD Facebook: Reach was flat, and Page Visits increased by 181% year over year for **August**. The Page Visits number illustrates how we are bringing **new** people to our page.
- APD Instagram: Reach decreased by 25% and visits decreased by 44%, year over year, for **August.**
- Top organic post for August was on August 1, which had a Reach of 4.5k and announced that the Westernettes Baton Twirling Corp. had placed 1st at Nationals.

- o Slip, Trip, and Fall assessment is beginning in September 2023 with October 2023 completion date of all sites.
- o Indoor walking track update: Waiting for review from the Village of Addison for building codes pertaining to emergency exits, in order to reopen walking track. In addition, after inspection of track, it was noticed that there is weakness to the guardrail structures. We are hiring an engineer to review safety of guardrails. More information pending.
- O Security camera RFP has been posted. Walkthrough completed with final bids due October 6th. Board presentation currently on target for October 2023.
- o The new safety committee continues monthly meetings.

• IT:

- o Continue with work with IT consultant on wifi in the parks grant project. Assessment to show options, pricing, and feasibility underway. Bid documents to be finalized in September.
- o ePACT software has completed configuration and has gone live with the Preschool program.
- o RecTrac and Web Trac enhancements underway. Club Fitness membership registration through Web Trac for the first time ever has been released on WebTrac.
